European Union Injects €40m to Combat Deforestation In Uganda

Entebbe - On April 9th 2024, the European Union (EU) Commissioner for Environment, Oceans and Fisheries, Mr. Virginijus Sinkevičius, announced the launch of projects worth Euros 40M (Sh167 billion) under the Forest Partnership with the Republic of Uganda. The address made during the high-level visit by Commissioner Sinkevičius was intended to address the causes of deforestation while supporting sustainable forestry as a step towards climate action. Mr. Sinkevičius appreciated such milestones, which have been a demonstration of common aspirations that contribute to achieving the European Green Deal's objectives and the Global Gateway - the EU's sustainable connectivity strategy cooperative that includes enhancing the role of forests in the bio-economy and nurturing our trade flows of wood material. H.E. the President Gen. (Rtd) Yoweri Kaguta Museveni commended the efforts of the initiative, recognizing its efforts in handling trespassers in the forests. "This is a good initiative because it will help us protect our forests and also deal with those who want to encroach on the forests," said President Museveni. The EU-Uganda forestry programme, together with the Government of Uganda, has shared a long-standing collaboration in natural resources management (forestry, water, climate change) for over 30 years. The past 15 years of this collaboration have mainly been in the field of commercial forestry.



President Museveni Welcomes Former Tanzanian President Jakaya Kikwete.

Entebbe – The former President of the United Republic of Tanzania, H.E. Jakaya Mrisho Kikwete paid a courtesy call on President Museveni at State House Entebbe on April 15th 2024. H.E. Museveni informed H.E Kikwete that as leaders, they must solve the problem of the market to ensure prosperity of the East African people. President Museveni further emphasised strategic security among the East African Community (EAC), saying this will help the nations

to safeguard their interests. H.E. Kikwete conveyed greetings from Tanzanian President, H.E. Samia Suluhu Hassan to President Museveni. President Kikwete officiated at the Guild Leaders' Annual Summit at Makerere University and also visited with the Julius Nyerere Leadership Centre in Kampala.





President Museveni Engages Italian Investors to Boost Uganda's Economic Growth.

Entebbe - A delegation led by Amb. Stefano Gatti, Director General of the Italian Agency for Development Cooperation, met with H.E. the President on April 7th, to discuss investment opportunities in Uganda. Expressing the need for private sector capital, President Museveni highlighted Uganda's natural resources and investment potential during the meeting at State House Entebbe. President Museveni lauded Prime Minister Giorgia Meloni's support and made a clarion call for European investors to join Uganda's development journey. He emphasized, among others, the significance of adding value to Uganda's coffee production, encouraged investments in the manufacturing of pharmaceuticals and veterinary drugs.

H.E. the President showcased Uganda's dairy industry's success story and assured the Italian investors of a ready market for their products. He also welcomed Italy's climate fund project, recognizing its role in environmental conservation and climate change mitigation. The Rt. Hon. Prime Minister who represent the President at the Italy-Africa Summit, highlighted Italy's commitment to


Uganda's development, and expressed optimism about potential investments. Amb. Stefano Gatti reaffirmed Italy's focus on Uganda as a priority country for development cooperation and he outlined plans for collaboration in coffee production, value addition, livestock, agro-food businesses, and healthcare. The meetina symbolizes Uganda's proactive approach to attracting foreign investment and enhancing economic growth through strategic collaborations anchored in commercial diplomacy.

HRH The Duke of Edinburgh Meets with H.E. the President



The Duke of Edinburgh travelled to Uganda on a three-day visit to grow awareness of HRH's International Award and the impact Non-Formal Education and Learning can have on young people and their communities. The Duke met H.E. Yoweri Kaguta Museveni and during their meeting, President Museveni expressed his eagerness to collaborate with British investors and to attract more tourists from the United Kingdom, highlighting the potential for mutual growth & prosperity.

H.E. the President also officially accepted the role of Patron to The Duke of Edinburgh's International Award in Uganda. Together with the State Minister of Foreign Affairs Hon. Okello Oryem, HRH The Duke attended the Award's Africa regional conference to discuss the sustainability of the Award in the Africa region.





Uganda-EU Business Forum Sparks Trade Opportunities.



PAMELA NABWIRE CONTRIBUTOR **Munyonyo** - The 3rd Uganda-European Union (EU) Business Forum, themed 'Boosting Trade and Investment: What can Uganda gain from the Global Gateway,' took place from 5th to 6th

March at Speke Resort, Munyonyo. The event, organized in collaboration with Private Sector Foundation Uganda, Uganda Investment Authority, and the Ministry of Finance, Planning, and Economic Development, brought together representatives from EU states including Portugal, Asia, Austria, The Czech Republic, and Poland, among others. The forum highlighted trade and investment opportunities in Uganda and Europe, focusing on key sectors such as agribusiness, mining, infrastructure, and tourism.

Amb. Jan Sadek, Head of the European Union in Uganda, highlighted the EU's significant share of Foreign Direct Investments in Uganda, amounting to over 40% of the total of €1.2 billion. He also noted a healthy trade turnover between the EU and Uganda, currently standing at €1.5 billion. Discussions also included the East African Exchange on Data Protection among East African Community (EAC) states, focused on enabling digital transformation, customer trust, privacy compliance, and cross-border data flows.

KEY INITIATIVES & PARTNERSHIPS ANNOUNCED:

- A €100 million agreement with Centenary Bank to support female borrowers and micro-enterprises in rural areas.
- A €50 million investment partnership with Housing Finance Bank.
- A **US\$40 million** European investment in Uganda's rural telecom expansion, which will see the installation of 506 new telecom towers to provide access to 5G data and mobile money services.
- Financing for Uganda's agribusiness
 SMEs through the Support to Agricultural Revitalization and Transformation
 (START) Facility. 7

President Museveni officiated the forum and emphasized the importance of global trade benefiting the entire world and called for meaningful discussions between Uganda and EU governments. He stressed that global affluence should benefit everyone and highlighted the role of the business community in engaging political actors. While closing the forum, the Right Honorable Prime Minister Robinah Nabbanja highlighted Uganda's significant trade with the EU, inviting investors to set up industries in Uganda to add value to its primary goods. She welcomed the 8 new projects worth 200 million euros launched by Team Europe and Uganda at the forum, aimed at supporting small businesses, agribusiness, women entrepreneurs, and digital infrastructure initiatives in Uganda.

The 3rd Uganda EU Business Forum was the largest and most influential joint event on conducting business & investing between the EU and Uganda, with 3600 registrations, 900 physical participants, 90 exhibitors, and a large online audience.



President Ramaphosa on Working Visit to Uganda; Discusses Regional Security, Trade, Diplomacy with President Museveni.

Entebbe - His Excellency, Matamela Cyril Ramaphosa, President of the Republic of South Africa, conducted a productive working visit to His Excellency, Yoweri Kaguta Museveni, President of the Republic of Uganda, from 15th to 16th April 2024. During the visit, President Ramaphosa held fruitful discussions with President Museveni on bilateral relations, regional, and continental issues of mutual interest, including the peace and security situation in the region, affirming their working together commitment to for sustainable peace, stability, and economic development on the continent. President Ramaphosa was accompanied by Hon. Dr Naledi Pandor, the Minister of International Relations and Cooperation of South Africa, and Hon. Khumbudzo Ntshavheni, Minister in the Presidency. President Museveni was joined by Hon. Jason Marksen Oboth-Oboth, the Minister of Defence & Veteran Affairs, Hon. John Mulimba, the Minister of State for Regional Affairs (who also officially received President Ramaphosa at the Airport), General Muhoozi Kainerugaba, the Chief of Defence Forces, and Uganda's High Commissioner to South Africa, Amb. Paul Amoru.

President Museveni Emphasizes Uganda's Conservation Commitment in Talks with Botswana's Former President.

Entebbe - H.E. Ian Khama, the former President of Botswana visited H.E. the President along with a delegation from Space for Giants, a conservation charity led by Dr. Max Graham. The two Principals discussed how Ugandans can obtain social economic value through conservation & innovation. Their Excellencies agreed on the importance of involving local communities to preserve Africa's natural resources during the meeting held on 25th April 2024. They purposely looked at the Pian-Upe game reserve, currently facing degradation, President Museveni expressing with his commitment to support conservationists in unlocking the area's natural value.





Uganda Gears up for Firstever Korea-Africa Summit.

Kampala - Hon. John Mulimba, Minister of State for Regional Cooperation, met with Mr. Jung Kihong, the South Korean government representative and Executive Director for the Korea-Africa Summit, on March 27, 2024. The two principals discussed preparations for the upcoming first-ever Africa summit in Seoul, in June 2024. Mr. Kihong emphasized the strong ties between Uganda & Korea, which the summit aims to further enhance. Не appreciated Uganda's support and highlighted that the summit will prioritize partnerships for shared growth, with a focus investment, and technology trade, on exchange. In a separate meeting, Prime Minister Rt. Hon. Nabbanja Robinah also held bilateral talks with the South Korean delegation, in a meeting which also included the South Korean Ambassador to Uganda, H.E. Park Sung-Soo, at the PM's office in Kampala.

Rt. Hon. Nabbanja emphasized Uganda's eagerness to benefit from the summit, particularly in areas such as technological transfer and paid tribute to South Korea's people for their support towards Uganda's development agenda. Mr. Jung Kihong acknowledged Uganda's significant role on the global stage as the Chair of the G77 + China and the Non-Aligned Movement (NAM). The 2024 Korea-Africa Summit is expected to further strengthen partnership between Korea and African countries, with President Yoweri Museveni expected to attend.

MOFA Revitalizing Regional Relations Through JPC Meetings

The Regional Economic Cooperation (REC) Department, under the direction of Amb. Richard Kabonero, has initiated meetings since March 2024 to strengthen cooperation between Uganda and three key African countries through the Joint Permanent Commission (JPC) framework which features meetings for both the public & private sector. These countries are Nigeria, Kenya, and Tanzania.

Uganda and Nigeria have historical agreements dating back to pre-independence years, some of which need review and possibly renewal. Amb. Nelson Ocheger, the High Commissioner of Uganda to Nigeria, has been actively exploring areas of cooperation, including education, defense, security, and tourism. Nigeria's significant investments in Uganda, highlighted by the success of the May 2023 business event, have led to the launch of Uganda Airlines routes from Entebbe to Lagos, Abuja, and Kaduna.


Additionally, REC has engaged in preliminary discussions with Kenya since March 2024, following the last agreed-upon JPC meetings in December 2019. Uganda and Kenya are scheduled to hold the second session of the Joint Ministerial Meeting from May 11 to May 14, 2024, aiming to finalize 19 MoUs in Kampala. This Joint Ministerial Meeting (JMC) aims to reduce Non-Tariff Barriers (NTBs) and increase Uganda's trade volume in the East African Community (EAC) subregion from 44.8% to 60% by 2025.

REC will also participate in the Uganda-Tanzania business meetings in May 2024, focusing on enhancing trade between the two countries. This engagement will highlight Uganda's trade and investment priorities on the Tanzanian agenda. Additionally, REC, along with the Ministry of Trade, other Ministries, Departments, and Agencies (MDAs), and the Private Sector, will participate in the 48th Dar es Salaam International Trade Fair in June 2024. This engagement aims to further boost trade relations between Uganda and Tanzania.

undertook a four-day field visit to the Albertine Graben region, led by Permanent Secretary Bagiire Vincent Waiswa. The delegation, comprising MOFA senior management, Heads of Mission, and technical officials from Uganda Embassies, was graciously hosted by the Petroleum Association of Uganda (PAU).

The visit, emblematic of Uganda's commitment to economic diplomacy, aimed to source investors in four priority areas: Agroprocessing, Tourism, Mineral Development, and Science and Technology Transfer. The collaboration between MOFA and the Ministry of Energy and Mineral Development was highlighted, particularly in enhancing the technical capacity of Uganda's Foreign Service regarding petroleum and mineral development programs. Hon. Ruth Nankabirwa Sentamu, Minister of Energy and Mineral Development, commended MOFA's proactive stance and urged the delegation to engage with Project Affected Persons, emphasizing responsible energy exploration and environmental conservation.



During the visit, the delegation immersed themselves in Uganda's petroleum and mineral sectors, visiting key sites such as the Uganda Petroleum Institute Kigumba, the Centre of Excellence for Oil and Gas Training, and the Kingfisher Development project. Engagements with local communities highlighted the social and environmental dimensions of oil exploration. The itinerary also included visits to critical infrastructure such as the Waste Management Facility in Luwero Industries, feeder pipeline activities, and industrial parks, offering insights into Uganda's growing energy and agricultural sectors.

My four days of Oil diplomacy in the Albertine

Diplomacy, often viewed through the lens of formal negotiations, holds a deeper meaning for me. Rooted in humility, good manners, and respect for all, it embodies grace in conduct and navigating interactions with ease. Diplomacy, to me, means doing what's right for the greater good, ensuring every voice is heard and respected. If given the chance, I would gladly embrace the title of diplomat, not in the traditional sense, but as a plenipotentiary of goodwill and understanding.

This week, I had the privilege of joining a delegation from Uganda's Foreign Missions in Beijing, Abu Dhabi, Paris, and Dar es Salaam, accompanied by officials from the Ministry of Foreign under the leadership of Affairs Permanent Secretary Mr. Vincent Bagiire. Our destination was the Albertine Graben region, where our primary objective was to observe the ongoing projects in the area. Such visits hold immense significance as they provide first-hand insight into the progress and challenges faced in these regions.

Throughout our journey, I witnessed first-hand the transformative impact of diplomacy in action. From the flagoff ceremony, where Mr. Bagiire emphasized the importance of economic diversification and environmental sustainability, to Minister Ruth Nankabirwa's impassioned plea for responsible resource management, every interaction underscored the principles of humility, respect, and collaboration.

When the delegation visited the Uganda Petroleum Institute, Kigumba (UPIK), it was evident that the dedication of the trainees and the collaborative efforts of government, private sector, and international partners were deeply impressive. Behind every statistic, every enrolment, and every diploma program lay a story of hope, opportunity, and empowerment. As the delegation toured the facilities, it became clear that UPIK represented more than just an educational institution; it symbolized a collective endeavour towards investing in the

next generation of technicians. Government officials, representatives from the private sector, and international allies had joined forces to ensure that students these had the necessary resources and support to excel in their chosen fields. Each statistic revealed not just numbers but the aspirations of young individuals striving for a better future. Behind every enrolment was a student eager to learn, grow, and contribute to their community.

Established in 2009, Uganda Petroleum Institute, Kigumba (UPIK) in Kiryandongo district trains technicians for Uganda's oil and gas industry. With over 1000 trainees enrolled, UPIK's success stems from a collaboration between the Government of Uganda, the Private Sector Foundation (PSFU), Total Energies EP Uganda LTD (TEPU), and the World Bank Albertine supported Region Sustainable Development Project (ARSDP).

The delegation also visited key sites within the Kingfisher Project. Their itinerarv encompassed a thorough inspection of vital locations, including the oil rig situated at well pad three, which served as a testament to Uganda's rapidly advancing capabilities in the oil sector. addition. the MoFA In delegation visited a waste management facility run by the National Enterprise Corporation (NEC), which is under the UPDF.

They also visited Kabalega International Airport, a big project that will greatly improve Uganda's ability to handle air cargo, and were impressed by how the airport is ready to handle large cargo flights, making it an important hub in the region.

China's Special Envoy for the Horn of Africa Visits Uganda

Kampala - On 3rd April 2024, the Minister of State for International Cooperation, Hon. Okello Henry Oryem, welcomed H.E. Xue Bing, China's Special Envoy for the Horn of Africa, to Uganda at the Ministry headquarters. Hon. Orvem expressed gratitude to the Government of China for its efforts in promoting peace, security, and development in the region. H.E. Xue Bing thanked Uganda for its hospitality and acknowledged the strong relations between China and Uganda. He emphasized China's commitment to Africa's prosperity and the importance of initiatives for peace in the Horn of Africa. The meeting included a comprehensive discussion on the situations in Sudan, Eastern DRC, Somalia, & South Sudan.





President Yoweri Kaguta Museveni also received a letter from President Xi Jinping of China expressing support for the East African Crude Oil Pipeline (EACOP) project, delivered by the Chinese delegation led by Mr. Bing. President Museveni welcomed President Xi Jinping's support and invitation to the Energy Minister to visit China for further discussions. Ambassador Xue Bing strengthening discussed bilateral ties, the upcoming Forum on Africa-China Cooperation (FOCAC), and a peace conference for the Horn of Africa with President Museveni, highlighting the importance of these areas for both countries.

President Museveni Advocates for African Nations to Enhance Exports Through Value Addition

Nairobi – President Yoweri Museveni on April 29 2024 returned to Uganda after attending the World Bank's International Development Association (IDA) – Africa Heads of summit which took place in Nairobi, Kenya. During the summit, President Museveni urged African countries to stop exporting raw materials but instead, add value at source to steer development. "This Haemorrhage of Africa must stop. The crisis you see in Africa is because of stagnation since independence. The population is increasing and yet the economies are not," said President Museveni.

President Museveni further attributed the current financial crisis in Africa to continuous ideological and strategic economic mistakes dating back to the 1960s where he vouched for socio-economic growth within the private sector. "For the private sector to grow, it needs low cost of production in transport, electricity, and low-cost funding for manufacturing," he urged. He also expressed sincere appreciation to the President of the World Bank for stirring conversation about prosperity rather than yielding profits. The International Development Association (IDA) is a development finance institution that offers concessional loans and grants to low-income countries. The IDA is a member of the World Bank Group and is headquartered in Washington, D.C. in the United States.


Israeli Ambassador Meets Regional Cooperation Minister

Unlocking Opportunities: Significance of the Uganda-Tanzania Oil & Gas Symposium.

The Uganda-Tanzania Oil & Gas Symposium emerges as a pivotal platform, fostering collaboration and illuminating opportunities within the energy sector in East Africa. Abuja - The longstanding bilateral relations between the Republics of Uganda have Nigeria and seen significant progress in various sectors, including trade and education, dating back to pre-independence years. Recently, Uganda's High Commissioner to Nigeria, Amb. Nelson Ocheger, met with Nigerian Minister of Foreign Affairs, Hon. Yusuf Maitama Tuggar, in Abuja to further enhance these ties.

During the meeting, both representatives expressed their commitment to strengthening economic, commercial, and political cooperation. They discussed plans to increase interactions in business, trade, investment, tourism, and knowledge sharing. The commencement of direct flights between Entebbe and Lagos by Uganda Airlines was noted as a positive development that has addressed some challenges in the business sector between the two countries.

The discussions also focused on the progress made in reviewing bilateral agreements in key sectors such as energy, oil and gas, defense and security cooperation, and education. In line with these efforts, Uganda has expressed readiness to host the forthcoming Joint Permanent Commission (JPC) meeting in Kampala. The JPC meeting is expected to facilitate the signing of agreements and Memoranda of Understanding (MoUs) to enable the private sectors in both countries to thrive.

Kampala - Uganda recently played host to a delegation of 60 new Indian investors for the Uganda-India Business Conclave, held on April 9, 2024, at the Ministry of Finance, Planning, and Economic Development. Hon. Matia Kasaija, Minister of Finance, who was the Chief Guest at the conclave, and Hon. Anite Evelyn, State Minister for Investment and Privatisation, welcomed the delegation. The Federation of Indian Chambers of Commerce and Industry (FICCI) Business Delegation, led by Chairman of Triyn Technologies Ltd. and Chairman of FICCI Africa Council, Mr. R. Ganapathi, focused on fostering business connections between Indian and Ugandan entities. The conclave aimed to promote sectors such as manufacturing, agriculture, infrastructure, renewable real estate, energy, healthcare, digital public infrastructure, ICT, medical and nursing, textile, and tourism in Uganda. Following the conclave, discussions continued on April 10, 2024, between the Indian delegation and Ugandan officials, including Minister of State for International Affairs, Hon. Oryem Okello. The discussions centered around the available lines of credit worth USD 205.5 million offered by the Government of India to Uganda. These lines of credit include a grant window for studying priority projects in areas such as grid reinforcement and extension, infrastructure for agriculture and dairy sector, and solar-powered water pumping systems. The Uganda-India Business Conclave was jointly organized by the Uganda High Commission New Delhi, High Commission of India in Kampala, FICCI, the India Business Forum, and other national chambers, showcasing the strong partnership between the two countries and the potential for further economic cooperation and investment.

Nairobi - The National Coordinators of the Northern Corridor Integration Projects (NCIPs) for Kenya and Uganda recently convened a consultative meeting on April 15, 2024, at the Ministry of East African Community in Nairobi. Ambassador Richard Kabonero represented Uganda, while Hon. Mr. Abdi Dubat represented Kenya. The meeting aimed to discuss several key issues, including the revival of NCIPs, tracking the implementation progress of the 14th Summit Directives in preparation for the 15th NCIPs Summit, and agreeing on the action plan for convening pending NCIPs meetings. Additionally, they Cluster reviewed the progress of implementation regional joint verification of the mechanism on the status of the East Africa Tourism Visa (EATV) under the NCIPS Memorandum of Understanding. Both principals praised the efforts of the Partner States in reviving NCIPs, particularly through ICT and Standard Gauge Railway (SGR) Cluster meetings. Uganda received special recognition for successfully managing and chairing two Cluster meetings, as well as engaging with Partner States to implement Summit instructions. In a unified effort, they both agreed to convene the NCIPs National Coordinators' meeting & pending Cluster meetings in May 2024 in Kampala.

He encouraged Partner States to adhere to the Sectoral Council meetings' calendar of activities.

The aim was to enhance bilateral relations and cooperation in various areas of shared interest. Led by Hon. Oryem Henry Okello, Minister of State for Foreign Affairs/International Affairs, Uganda's delegation also included Amb. Margaret Otteskov, Uganda's Envoy accredited to the NORDICS. The Finnish delegation, led by H.E Pasi Hellman, Under Secretary of State for International Development, engaged in discussions on bilateral, regional, and international issues, emphasizing their commitment to peace, security, sustainable development, and human rights. Both delegations expressed satisfaction with the existing partnership and pledged to further strengthen cooperation in regional politics, trade, civil society, human rights, education, and environmental issues. H.E. Mr. Pasi Hellman thanked Uganda for its hospitality and announced plans for the Second Political Consultations to be held in Finland on mutually agreed dates. In 2022, Uganda exported goods worth \$6.82 million to Finland and these included Coffee, vegetables and oil seeds. In the last 27 years, the exports of Uganda to Finland have increased at an annualized rate of 7.41 to \$6.82M in 2022.

Uganda Endorsed to Join Khartoum Process Steering Committee at Senior Officials' Meeting in Egypt.

Cairo – Uganda's membership in the Khartoum Process Steering Committee was confirmed during the Senior Officials' Meeting held in Cairo, Egypt, on April 17-18, 2024. The Khartoum Process, established in November 2014, serves as a platform for political cooperation among countries along the EU-Horn of Africa Migration Route, focusing on collaboration and information exchange related to migration. The Uganda delegation, consisting of senior officials from the Ministries of Internal Affairs and Foreign Affairs, joins a diverse group of countries in the Khartoum Process, including several EU Member States and African nations. The Steering Committee, comprising five EU Member States and five African Member States, along with partners like the European Union Commission and the African Union Commission, guides the Khartoum Process's strategic direction.

Uganda's endorsement to the Steering Committee comes after a decision in 2023 to expand membership, allowing for six members from each block. **Ms. Agnes Birungi, a Consular Officer** in the Ministry of Foreign Affairs and a member of the delegation, highlighted "Uganda's wealth of experience in migration management, aiming to contribute significantly to the Khartoum Process's objectives." The Khartoum Process aims to foster a common understanding of human trafficking and smuggling of migrants, promote balanced partnerships, and uphold shared responsibility and cooperation, with Uganda poised to contribute actively to these initiatives.



Dr. Martin J. O. Aliker was an acclaimed Ugandan diplomat, businessman and one of the country's first dental surgeons. Born in Gulu District, Uganda, Dr. Aliker was an alumnus of Kings College Budo and Makerere University. He earned his Doctor of Dental Surgery (DDS) degree from Northwestern University, Chicago, in 1959. Throughout his life, Dr. Aliker was an influential business leader and investor, serving on the boards of companies, including various Uganda Breweries Limited, Cooper Motor Corporation, Longman Publishing, Phoenix Assurance Company of East Africa, Coca-Cola Africa Region, Nation Media Group, and Heritage Oil, among others. Despite being forced into exile in Nairobi, Kenya, in 1972, Dr. Aliker returned to Uganda permanently in 1996. Dr. Aliker's contributions to Uganda extended beyond business. He served as an advisor to Presidents Yusuf Lule and Godfrey Binaisa (1979-80), as well as Senior Adviser, Special Duties, to President Yoweri Museveni in 1986.

He was Minister of State for Foreign Affairs (1996-99).

Dr. Aliker also held roles as Chairperson, Queen Elizabeth Diamond Jubilee Trust Fund, Uganda Chapter, 2012-13, and Chancellor of Gulu University from 2002 to 2014. In 2018, Dr. Aliker published his memoirs titled "The Bell Is Ringing: Martin Aliker's Story," detailing his life from his childhood in Aworanga, Gulu, to his achievements in education, politics, and diplomacy. Dr. Martin J. O. Aliker leaves behind a legacy of excellence, leadership, and service to Uganda. His impact on the country and to Uganda's Foreign Policy will always be remembered and cherished.



Testimonial by Ms. Jacent Rose Nangooba: A Ugandan's Journey Through Black History Month in America



Washington - Representing Uganda, I embarked on a transformative journey to the United States during 2024 Black History Month celebrations. the Organized and sponsored by a coalition of individuals and organizations including Dr. Deborah and Reginald Freeman, founders of BTG, HBCUs in Virginia and Maryland, community organizations, churches, and the Ugandan Embassy in Washington DC, this two-week trip was a profound exploration of Black American culture and history, intertwined with the beauty of the USA. Departing from Entebbe International Airport in Uganda, my heart raced with a mix of terror and excitement as I boarded my firstever flight, with a connection in Istanbul before landing at Newark International Airport in New Jersey. Stepping out into the chill of a snowy New Jersey evening, I marveled at the unfamiliar cold, a stark contrast to the warmth of my homeland. Despite the biting cold, the dazzling lights of New York City welcomed me for a late-night exploration, revealing a skyline adorned with towering skyscrapers and iconic landmarks like Times Square, the Empire State Building, and Rockefeller Center.

In the heart of Uganda (the pearl of Africa), lies a breathtaking mountain range known as the Rwenzori Mountains, also called the "Mountains of the Moon." These mountains offer a unique backdrop for the Tusker Lite Rwenzori Marathon, a World Athletics Federation certified event featuring races of 42KM, 21KM, and a fun run of 5KM.

The marathon showcases the Rwenzori Theluji Experience, where the 42KM Elephant run starts from the Equator line to the mountains at 1182 meters above sea level through Kilembe mountain ranges. The 21KM Leopard run takes you from Kasese town to 1182 meters above sea level, while the 5KM fun run contributes to conservation efforts under the **"My Tree, My Theluji"** tree planting campaign.

As you test your limits in the marathon, you'll also immerse yourself in the Rwenzori Theluji stunning views of the savannah wilderness, lowlands of Queen Elizabeth National Park, and the diverse theluji cultural performances along the routes, with glimpses into the local livelihoods and coffee plantations.

The **Rwenzori Theluji Festival**, scheduled for 23rd August to 7th September 2024 in Kasese Municipality, is a celebration of biodiversity conservation, tourism promotion, and cultural heritage. This festival offers visitors a glimpse into the lives of the 52 tribes that call this region home, through traditional music, dance, and local cuisine, highlighting the deep connection between the people of Rwenzori and their surroundings. The festival not only celebrates the natural beauty and cultural richness of the region but also aims to conserve the Rwenzori Mountain ranges from the effects of global warming and climate change. It offers an unforgettable experience that will leave you with a lasting impression of this unique part of the world.
